GENERAL DISCUSSION OF ISSUES BEFORE THE LEGISLATURE:

- The House Education Task Force on Education Sustainability
 - The funding talk is troubling; asking schools to cut spending but at the same time suggesting services that are more expensive, i.e. regional schools. In addition, the 70/30 current debt reimbursement reduced to 50/50 split.
 - Not in favor of statewide curriculum. Not good for district to be pushed into one size fits all.

• The Hay Report

The Legislative Committee agreed to encourage the school board continuation in moving forward in exploring the Hay recommendation for health care cost savings to the school district. Bruce Johnson is urging the Hay Group to come and answer questions. The potential for savings, as per Dave Jones' calculation, (spreadsheet provided) would be between 7.79% to 11.56% of our school district's current expenditure.

NEA has not taken or submitted an official stance.

The Governor's Budget Proposal

(Senator Peter Micciche was invited to join us but was unable to make it)

- Energy money for schools approximately 1.7 million for KPBSD.
- Statewide Distance Education This would make sure students have access to education and would be paid for with grant monies. It would be very valuable to our state and district.
- NEA and Kenai Peninsula Borough School District common goals.
 - NEA and KPBSD will meet to discuss common goals.
