Mrs. Hilts called the meeting to order at 6:00 p.m.

APPROVAL OF AGENDA:

The agenda was approved with a revision to 10a. (1) 2015-16 New Teacher Contracts.

APPROVAL OF MINUTES:

The School Board Minutes of August 3, 2015, were approved as printed.

SCHOOL REPORT:

Mr. Christopher Brown, Homer Flex School administrator, introduced students Miss Jesse Hiller, Miss Jenna Kilcher and Miss Sierra Wylde, and school mental health counselor, Ms. Augusta Lind. Mr. Brown recognized the school staff members in the audience. The presenting team shared a student produced video and a PowerPoint that highlighted the school’s strengths, sense of community, student recruitment procedures, school culture, programs, garden, community involvement and mental health program. In conclusion, Mr. Brown stated that Homer Flex is a strong, positive school.

Mr. Jeff Ambrosier, Ninilchik School principal, introduced teacher, Mr. Mike Tozzo and student council members, Miss Naomi Hess, and Miss Tatiana Cooper. The students discussed the school’s mission statement, programs and student successes. Mr. Ambrosier described challenges that make Ninilchik School unique, including a high transient population. Miss Hess explained the school’s Positive Behavior Intervention and Supports (PBIS) program and Jump Start program use. Miss Cooper highlighted the value of Project Grad and the Ninilchik Traditional Council. Mr. Tozzo, student council advisor, coach and teacher discussed school athletics which include homeschool students. Mr. Ambrosier promoted the school reading program which utilizes 90 minutes of uninterrupted time. He shared the school’s college scholarship totals for the past two years. Mr. Ambrosier expressed his pride in the school staff for their longevity and commitment.

PUBLIC PRESENTATIONS:

Ms. Heidi Adams, Chapman School parent group president, discussed recent school improvements and thanked the Board, the site council and the principal for their work in helping address these needs.

Representative Paul Seaton discussed upcoming legislative challenges. He noted two upcoming town hall meetings, one in Ninilchik on September 10 from 6-8 p.m. and one in Homer on September 11 from 7-9 p.m., and invited the Board members to attend. He encouraged the Board to be active in the discussion on the use of longitudinal databases, either individually or through the Association of Alaska School Boards (AASB). He welcomed the Board to contact him to discuss any issue that would help improve education on the Peninsula.

HEARING OF DELEGATIONS:

Mobilizing For Action through Planning and Partnerships (MAPP) representatives, Ms. Anna Meredith and Ms. Racheal Romberg, explained Adverse Childhood Experiences (ACES) and the services and programs provided for students through MAPP.

COMMUNICATIONS AND PETITIONS:

Mr. Dusek reported that the State approved the district’s FY16 budget and thanked Mr. Jones and Mrs. Olson for their work. He stated that the Comprehensive Annual Financial Report (CAFR) will be presented at the October 5 board meeting.

ASSEMBLY:**

Mrs. Patty Sirois, K.P.E.S.A. president, apologized for missing the August board meeting. She expressed appreciation for the school reports and the Caring for the Kenai program. She reported that the associations participated in the Kenai River Festival, Ninilchik State Fair and Industry Appreciation Day and stated that their booths were well received. She reported on her recent school site visits to Razdolna, Voznesenka and Kachemak-Selo schools. She discussed staffing issues and requested that the staffing formulas be reviewed and updated. She stated that she is hopeful that the upcoming mediation will resolve negotiation issues. She noted that her granddaughter is 10 months old and walking.

Mr. David Brighton, KPEA president, thanked the Board for their proactive work on the budget and encouraged the public to contact legislators regarding the effects of cuts to the education budget. He thanked Representative Seaton for attending the meeting and speaking.

Mr. Pete Swanson, KPAA president, noted the challenge for Mr. Brown to present a school report during his first year as the Homer Flex administrator. He thanked the Board for giving schools the opportunity to present during board meetings. He encouraged Board members to visit schools and welcomed them to McNeil Canyon Elementary at any time. He thanked the Board for their service.

**SUPERINTENDENT'S
REPORT:**

Mr. Dusek reported that the school year started well. He stated that enrollment is down almost 100 students, the numbers will be watched and funding adjusted as needed. He noted the ALICE emergency guidelines for parents and guardians memo in the general information packet. He reported on his recent meetings with state legislators to discuss the state fiscal situation. He informed that the Student in Transition Program service numbers are up 34% from this time last year. He announced three upcoming Key Communicators meetings; the first at Seward Middle School on September 9, second at Soldotna High School on September 22 and third at Homer High School on September 28. He noted that mediation is scheduled for September 21 and 22. He stated that the next administrator meeting will be held on September 23 at the Challenger Learning Center. He invited the Board to attend the Project SEARCH event on September 24 at the Challenger Learning Center. He informed the Board that he will attend the Alaska Superintendents Association meeting on September 24-26 in King Salmon, AK. He congratulated Mr. and Mrs. Joe Arness on their recent marriage.

FINANCIAL REPORT:

Mr. Jones presented the financial report of the District for the period ending July 31, 2015.

BOARD REPORTS:

Mrs. Downing reported that the Legislative Committee met earlier in the day to plan for the legislative session and upcoming challenges.

Mr. Navarre reported on his trip to the borough's sister city, Nikita, Japan noting that he was there as a representative of the Board but paid his own expenses and thanked the board for the opportunity.

Mrs. Hilts reported that the Board held work sessions entitled Mobilizing For Action through Planning and Partnerships (MAPP), Annual Assessment Report, AASB Resolutions and State and Federal Legislative Priorities, Communications Update and Budget Update. The Board discussed AASB Nominations, School Board Development and the possibility of a school board blog. All members present at the meeting, attended the work sessions.

Mrs. Hilts thanked the Homer culinary arts students for the Mexican dinner. She stated that representatives from the Ninilchik Traditional Council and the Seldovia Village Tribes joined the Board for dinner.
