    - ii. Kenai Football Officials Association needs to nominate 5 officials for football, and they have only been nominating 3 over the past few years for state level refereeing. Recommendation for ASAA Board to seek nominations from the schools rather than the association.
    - iii. State tournament bid packages will be discussed at the Dec meeting
    - iv. ASAA Hall of Fame nominations due by Dec 15
    - v. ASAA supports the Unified Track program. SoHi had Unified Track last year and we are working on continuing that program.

- vi. Proposal for changing level 4 TAD violation to a lifetime ban. Looking for feedback to bring to the ASAA Board. Discussion regarding the weight of a level three violation and the requirements of the student to get back into their sport, and the need for a level 4 violation.

- viii. The board created a waiver process to handle the schools wanting to form a co-op between two different districts instead of there being a blanket approval
