The agenda was approved as written.

The School Board Minutes of May 3, 2010, were approved as printed.

Dr. Atwater reported that the National Assessment of Educational Progress (NAEP) test will be given to students at the end of January through March with 22 District schools participating. He announced that Cooper Landing School was formally approved by the Department of Education and Early Development to offer kindergarten through twelfth grade school. He reported that the Project GRAD Summer Institute is currently underway which includes participation in the Kachemak Bay Writer's Conference. He announced that the District will receive federal funds for 4 District schools (Mt. View Elementary, Chapman Elementary, Nanwalek Elementary/High, and Tebughna Elementary/High) to participate in the Fresh Fruit and Vegetable Program.

Mrs. Druce, KPEA president, distributed campaign pins advertising opposition to state Proposition 1, known as the "gag law" and reported that NEA-Alaska and NEA-National are financially supporting the campaign to defeat the initiative. She thanked Dr. Atwater for allowing KPEA to host a table at the teacher inservice to distribute informational literature about the proposition. reported that KPEA will paint faces during the Kenai River Festival June 12 and 13 in an effort to promote classroom teachers and support professionals. She expressed gratitude for the list of nontenure teacher contracts before the Board for approval. She urged the Board and administration to continue to work with the Assembly to improve the budget process. She stated that she will attend the June 8 Assembly meeting. She stated that she is impressed and grateful for the new teacher evaluation process that will be implemented during the 2010-2011 school year.

Margie Warner, KPESA president, reported that U.S. Senator Lisa Murkowski spoke to the NEA Political Action Committee about the reauthorization of ESEA and how the Government Pension Offset Windfall Elimination Provision (GPO-WEP) will affect Alaskan retirees.

Dr. Atwater reported that all of the District intensive needs students were certified by the state. He announced that for the 20th consecutive year, the District has won the Alaska Business Officials Certificate of Achievement for Excellence in Financial Reporting. He provided preliminary test results noting improvement in math and reading and a small dip in writing. He noted that the District has 275 homeless students with the highest number living in Homer. He announced that over 10% of the District graduates now come from nontraditional high schools which supports the need for choice in education. He commended Mrs. Olson for an outstanding job standing in for Dave Jones while he was out of the office.

Mr. Jones reviewed the report of leases and agreements for the 2010-2011 school year.

Mr. Jones presented the financial report of the District for the period ending April 30, 2010.

Mrs. Downing reported that she attended graduation ceremonies at Homer High and Homer Flex. She reported that she was asked to provide a welcome speech on behalf of the School Board to the Project GRAD Summer Institute students. She reported that over 40 students were participating in college preparation activities. She reported that she was asked to be the keynote speaker at the Homer Middle School eighth grade promotion.

Mrs. Hilts reported that she attended the graduation ceremonies at Nanwalek, Kachemak Selo, Voznesenka and Seldovia and provided details about each.

Mr. Holt reported that he attended graduation ceremonies at Kenai Alternative, Skyview and Nikolaevsk. He stated that each of the graduations were memorable and unique and that it is good to have diversity in schools and diversity of programs.

Mrs. Crawford reported that she attended graduation ceremonies at Kenai Central High, Soldotna High and River City High.

Mr. Anderson reported that he attended graduation ceremonies at River City Academy High and Susan B. English High. He reported that he attended the BP Teachers of Excellence and was pleased that Mrs. Courtright was selected as the Teacher of the Year.

Mrs. Moock, Soldotna Middle principal, reported that the Informational Services Department staff will replace 164 computers at the school and thanked Mr. White for coordinating the effort. She praised the IS Department staff for their efficiency. She thanked Mr. Vlasak and Mr. Henson for implementing a software program that provides test data that can be sorted by grade level.

### **BOARD COMMENTS:**

Mr. Holt reported that he recently had lunch with two former District graduates who have been successful since high school graduation and noted that there are many other students who are just as successful.

Mrs. Crawford stated that the graduation ceremonies were all well attended and that they provide a wonderful opportunity for communication and outreach with those who do not have children in school. She stated that she is excited about the new teacher evaluation form.

Mr. Anderson stated that he is in his seventh year on the Board and is pleased to participate in the graduation ceremonies. He stated that he is not pleased that the District will be using a portion of the fund balance next year. He cautioned that there will be difficult years ahead for the state and that the District should hold on to the fund balance for as long as possible.

Ms. Hohl thanked Mrs. Druce for the "Vote No on Proposition 1" campaign buttons and for assisting with the teacher evaluation pilot program. She reported that she attended the SeaView Community Services Board meeting. She agreed with Mrs. Moock's positive comments regarding the Information Services Department. At Seward Elementary she attended the Boys and Girls Club Arbor Day celebration, mural unveiling, and the memorial tree dedication in honor of former school psychologist, Ann Knofel.

Mrs. Vadla thanked Mrs. Druce for distributing the campaign buttons and added that Proposition 1 is not an anti-corruption act. She stated that the new teacher evaluation tool is exciting and that she looks forward to the outcome. She stated that she will attend the Analytical Writing Assessment Committee meetings. She expressed appreciation for the worksessions prior to the Board meeting and thanked Mr. Jones and Dr. Atwater for the information provided. She stated that she enjoyed the article written by Dr. Atwater in the June edition of the <u>School Administrator</u> magazine titled, "Can We Live Without Federal Involvement." She reported that she attended the Drug Testing Task Force meeting prior to the worksessions and that the group is divided on the decision about whether to test students.

Mrs. Hilts stated that the Board had a productive day and that she was pleased that Mr. Jones is back at work.

Mr. Navarre stated that there needs to be more communication between the Assembly, School Board and the two administrations and that a meeting in September or October will be beneficial to next year's budget process. He thanked Mr. Jones, Mrs. Olson and the administration for their work throughout the budget process. He thanked the Borough Assembly members for their continued communication and added that he is looking forward to a smoother process next year.

Mrs. Downing stated that she is looking forward to more stability within the administration of the Homer schools. She stated that she attended the recent principal interviews and is encouraged by the new staff. She was impressed by the \$1.5 million of scholarship money awarded to Homer High students. She stated that she is looking forward to hearing about the personal education plan work being done in the counselors' meeting. She asked for an excused absence for the July 12 meeting.

Mr. Arness explained that the Board meeting audio was being web streamed on a trial basis and if successful, would continue. He stated that the use of web streaming is an attempt to become more accessible to Board meetings by the outlying areas of the Borough. He announced that an email link from the Board's website has been added to allow public comment on agenda items and can be submitted anytime prior to the start of the meeting. He reminded Board members of the June 8 Planning Session at the Kenai River Center beginning at 8:45 a.m.
