BACKGROUND INFORMATION				

The District previously had a five-year contract to provide student transportation services with First Student that ran from July 1, 2006, through June 30, 2011. A Request For Proposals (RFP) for another five year contract was issued with a due date of March 1, 2011. The one proposal that was received had higher than acceptable costs and a one year contract extension was negotiated with First Student. A new RFP for a five-year contract was issued on January 03, 2012, and one proposal was received by the February 17, 2012 deadline.

First Student was the lone proposer, and their daily rates submitted for all three service areas were \$516.28 for a Regular Education Route and \$684.84 for a Special Education Route. Based on these submitted prices, we estimate that the costs of running the exact same services as provided this year would equal \$7,590,700. We conveyed this estimate to the Department of Education and Early Development so they would have the latest figures as they worked with the legislature on SB 182.

SB 182 was passed with a FY13 per student amount of \$944 for the Kenai Peninsula Borough School District. When that amount is multiplied by our estimated transportation student count for next year it results in the \$7,590,700 needed to provide the same services for FY13 as we provided for FY12.

## ADMINISTRATIVE RECOMMENDATION

Administration recommends the Board of Education approve a five-year contract for transportation services from July 1, 2012 to June 30, 2017 with First Student, Inc. at the costs submitted in their RFP.
