APPROVAL OF AGENDA:

The agenda was approved as written.

**APPROVAL OF MINUTES:** 

The School Board Minutes of August 6, 2012, were approved as printed.

AWARDS AND PRESENTATIONS:

The Board presented a Golden Apple Award to Ms. Sara Reinert, University of Alaska Math Teacher, for her service to the students of Homer and the district.

Mr. Bruce Johnson, Executive Director, Alaska Council of School Administrators (ACSA)/Alaska Association of School Administrators (AASA) presented Dr. Steve Atwater with the AASA 2013 Alaska Superintendent of the Year award.

#### **SCHOOL REPORTS:**

Mr. Jeffrey Ambrosier, principal, Ninilchik School, gave a PowerPoint presentation with the assistance of two members of his student council, Miss Kaylee Smith and Mr. Ryan Bear. The presentation addressed test scores; "Power Hour" (a program designed to encourage student attendance); positive management process (PBIS); Success for All (SFA) reading program; after school tutoring; archery club; music program; and math club. He thanked the school staff, parents and community members for their assistance in helping Ninilchik students achieve.

Ms. Kiki Abrahamson, principal, Fireweed Academy, gave a computer presentation that highlighted the school's vision; mission; Six Learner Outcomes program; educational programs and plans to support the district goals. She stated that as the school principal, she will guide collaboration, address school improvement and staff development, and she shared her plans for Fireweed Academy.

# COMMUNICATIONS AND PETITIONS:

Dr. Atwater reported that the general information packet contains a memo from Assistant Superintendent Sean Dusek concerning the needs of the Soldotna area schools. He stated that the Soldotna area principals, board members and district administration have been meeting to discuss what, if anything, should be done to better meet the needs of Soldotna area students. He announced that a survey has been made available and that the next meeting will be held on September 18. He announced that Ms. Deb Evenson, Fetal Alcohol Spectrum Disorder specialist will provide trainings across the district. He offered to answer questions regarding the memo in the general information packet from finance director, Laurie Olson, regarding the grant equipment fund transfer.

ADVISORY COMMITTEE, SITE COUNCIL AND/OR P.T.A., K.P.A.A., K.P.E.A., K.P.E.S.A, BOROUGH ASSEMBLY: Mrs. LaDawn Druce, KPEA president, congratulated Dr. Steve Atwater for being chosen as the AASA 2013 Superintendent of the Year. She requested that the board support AASB resolution item 2.24 to provide forward funding for education and 4.8, to reestablish a defined benefit retirement program. She discussed the recent and upcoming elections and encouraged the public to research and to support senate candidates Kathy Giesel and Ron Devon, and borough assembly candidate, Hal Smalley. She discussed the state regulations regarding teacher evaluations that are to be presented to the state school board on December 6, 2012 and provided copies of the regulations to the board. She encouraged the district to provide their recommendations to the state school board regarding these regulations.

Mrs. Margie Warner, KPESA president, congratulated Dr. Steve Atwater for being chosen as the AASA 2013 Superintendent of the Year. She thanked Ninilchik School and Fireweed Academy for their presentation, progress and achievements. She urged the board and administration, with negotiations still not settled, to visit the schools and spend time talking to the support staff in order to help understand what they do and how the employees feel about their jobs. She urged the board and administration to settle and provide for a fair contract.

SUPERINTENDENT'S REPORT:

Dr. Atwater congratulated West Homer Elementary for receiving the U.S. Department of Education Blue Ribbon School Award. He reported that Soldotna Elementary, Kaleidoscope Charter, Seward Elementary and Paul Banks Elementary earned Bronze Awards in the U.S.D.A Healthier Schools Challenge and that program representatives from San Francisco will be in Kenai on September 20, 2012 to present their awards. He announced that the year-end financial audit was completed and that there were no exceptions noted on the audit. He thanked Mrs. Laurie Olson and Mrs. Elizabeth Hayes for their excellent work in preparing for the audit. He thanked three district custodians and school principal, Todd Syverson, for their clean-up efforts at Soldotna High School after recent vandalism.

FINANCIAL REPORT:

Mr. Jones presented financial reports of the District for the periods ending July 31 and August 31, 2012.

**BOARD REPORTS:** 

Mrs. Crawford reported that she attended the district's recent Analytical Writing Assessment (AWA) meeting and reported on the plans for the AWA program in district schools.

Mrs. Vadla reported that on August 14 she attended the regional district-wide inservice and participated in a writing calibration workshop for high school teachers. She stated that on August 20 she attended the Skyview High School Site Council meeting and learned about the school's new discipline program, and on August 30 she attended the Soldotna schools administrators' meeting where they discussed enrollment and meeting student needs. She stated while traveling to today's board meeting (September 10, 2012), she visited Tustumena Elementary and Ninilchik School.

Mr. Navarre moved the Board amend the motion by striking all previous language and replacing it with "The administration will establish a separate special revenue fund to administer the \$1,000,000 FY13 state capital budget grant and to administer purchases in accordance with the same board policy and administrative regulations that govern the current equipment fund." Mr. Holt seconded.

Dr. Atwater recommended the Board approve the proposed administrative recommendations regarding the 2012 AASB Core Resolutions.

Mrs. Crawford moved the Board approve the proposed 2012 AASB Core Resolutions with the proposed KPBSD administrative recommendations and the AASB Board recommendations. Mr. Holt seconded.
