## MEMORANDUM

TO: Board of Education

SUBJECT: Budget Transfers

Budget transfer 120 in the amount of \$11,765 has been requested by Soldotna High School. This transfer would move a portion of the Legislative Equipment Fund monies from the equipment account to the equipment-technology account to pay for computers to be used in the science, library, and Reconnecting Youth programs.

Budget transfer 159 in the amounts of \$15,916 and \$10,555 has been requested by the Instruction Department. This would include transfers from the Kenai Performance High School teacher salary monies to the pro-tech services account for consulting fees, and to the employee travel account for training of District employees in the start-up of the proposed high school, respectively.

Budget transfer 174 in the amount of \$24,000 has been requested by the Connections Program. This transfer will move a portion of supply allocation monies to the professional/technical services account to be used for Kenai Peninsula Community College classes, fall/spring, for Connections students.

These budget transfers exceed \$10,000; therefore, they require Board of Education approval per Board Policy 3120. Administration recommends approval by the Board of Education.
