I am requesting to be released from my contract as English teacher for Spring Creek School. My resignation is being tendered due to self-evident, increased stress levels attributed to my seven years teaching experience working with felony-convicted students in a maximum security prison environment. Working in the maximum prison setting is having a negative impact on my personal health as well as the welfare of my family.

I can no longer continue to work in this environment, at the same time ignoring the dynamics of youthful offender criminal behavior in addition to working the year round schedule. This stress is affecting my family's well being due to their concerns about my personal safety, the result of working inside the maximum security prison with youthful offenders whose criminal acts are widely publicized in the media prior to being assigned to the program.

This decision has not come lightly for me. I have discussed this at length with my building administrator over the past few months. We have addressed my options at length, and believe that leaving at this time would be in best interest of the Spring Creek School program, the Correctional Center staff, and the overall welfare of my family and myself.
