#### VI. Discussion Items

- a. Language Change in HS Handbook, page 11 "IV. STUDENT ELIGIBILITY, Section C., 4. Class Changes Add/Drop" Jesse Settlemyer stated the language within this section and the verbiage "Add/Drop" is a bit confusing and could use some revision. Section 'a' is intended for the same exact course code, whereas section 'b' is a bit more confusing. Jesse and Kari to provide suggested language for the next meeting to be discussed as an Action Item.
- b. MS Volleyball Language (discrepancy) Kari Dendurent states there is some discrepancy in the MS Handbook, page 36, compared to what is actually taking place during volleyball games. The suggestion is to remove B. "1. No player may participate on more than one team on the same day." This will be discussed as an Action Item at next meeting.
- c. Suggested language changes to KPSAA regarding eligibility Phil Leck, teacher/coaches stated the language is confusing for high school eligibility/grade checks. He would like to see additional clarification on 1) eligibility for credit recovery (2<sup>nd</sup> semester) 2) late spring, clarification for summer classes. Phil will provide suggested language to Kari for the next meeting to be discussed as an Action Item.
- Recommended Stipend Changes Tabled, to be readdressed at a later date/time.
- e. ASAA Updates Steve Klaich
  - Hall of Fame ceremony May 3, ASAA is asking regions to form subcommittees to get one person nominated from each region each year as well as keep documentation on athletes and coaches' accomplishments.
  - Classification Football, more information needed for April meeting, March 27-28 football coaches meeting wants input, Soldotna, Wasilla, 9-man questions regarding support from committee and coaches association.
  - Classification Basketball, Board is looking at other factors in addition to enrollment, not just basketball, more input by April.

- Baseball D-2 proposal #3 passed, 8 team State, 11 games, R3 southcentral
   (3), R6 rail belt (2) and 3 at-large berths. Petersburg in southeast conf. with no automatic berths 2021.
- Baseball D-1 passed proposal 18 with 1 at-large berth, 2021.
- Planet HS continue to improve and make system more user friendly, adding TAD and waivers by fall 2020.
- E-sports going well for the first year, spring 56 teams with 307 kids registered, Fortnite is NOT ASAA sanctioned (company bought Rocket League).
- Discussed "Out of Season Contact" and need to finalize language by the April
  meeting, 6 hours per week practice maximum outside of the season, start fall
  2020 if passed, Remove G? Dead period between Thanksgiving and first
  basketball practice, still discussing if coaches are allowed to play (part of the
  6 hours?).
- Swim/Dive uniform rule change submitted to NFHS, they should make a
  decision by early April, if rule change not passed ASAA will need to decide at
  our April meeting.
- Cold weather policy-hockey issue, SMAC looking at -20 degrees, ASAA looking into District policies, will report in April.
- Certifying turf fields and wrestling mats an issue for safety and liability, from NIAAA Legal session, Don Winchester certifies fields.
- Planet HS open for fall registration April 10.
- Kodiak hockey placed into Rail belt conference, \$3000 varsity and \$4000 for JV and Varsity.
- Tri-Valley made a request to restore Greatland Hockey, possibly as a D-3. Need Region II input and support, route requests through regions.
- Hockey DI, Region 6 requests berth change-4 Cook Inlet, 2 Railbelt, 2 at-large which includes D2 champion in the at-large pool (not automatic), need to discuss at region level, Region 4 is asking 5 Cook Inlet, 2 Railbelt, 1 at-large. The goal seems to be to eliminate the D-2 team from the D-1 State tournament.
- Alternative Ed students changing school of eligibility have an advantage over the brick and mortar school students. Looking at making the change end of current semester, not when the form is submitted. Also looking at language to make alternative ed students declare school of eligibility within the first 15 days or the school of eligibility is the public school for which their parent's

- Adopted policy regarding pep bands at State events, especially March Madness, numbers, fees, time available, sponsors, form at asaa.org to notify ASAA, must work with the floor manager.
- HOF nominees adopted.
- Jeff Ambrosier selected as the Region II member of HOF committee for another 2-year term.
- Jeff Erickson (Unalakleet) selected as the new at-large HOF member.
- 9-man football (from Region 3), teams may, by mutual consent, play some games at 9- man while other games at 11-man. Administrator or AD responsible for the decision-making does include playoffs (Passed).
- Purple Star Schools are those that meet established criteria for support of military children (substantial), does include Coast Guard.
- Spring 2020 meeting in Haines.
- Spring 2021 meeting hosted by Region 6.
- f. Extra-Curricular travel and substitute coverage for Nanwalek/Port Graham Administrator at across the bay schools is seeking additional substitute coverage to help with sporting events (in case of emergency situations), to be discussed as an Action Item at next meeting.
