RE: Review of Weighted Grades

Background: At our October meeting worksession we discussed our policy (AR 6146.1) that provides a weighted grade for students taking Advanced Placement (AP) courses. You asked that I review our use of AP courses and in particular, research the level of importance that students place on weighted grades when considering taking an AP class.

Each of our secondary and K-12 principals received a survey that asked 8 questions. Seven of our secondary schools (Connections, Homer High School, Kenai Central, Nikiski Middle-High, Seward High, Skyview and Soldotna High) offer AP courses. The results of this survey are included with this memo. As you can see, the responses to the survey questions varied, but most students taking AP classes state that the weighted grade was significant or very significant when considering whether to take the class. Also of interest is the disparity of the participation in the UA Scholars Program by those students taking AP courses. Ninety-four percent of Soldotna High School students who earn the UA Scholars distinction use the weighted grade benefit while only 14% of the Kenai Central High students in this same category take advantage of this.

It is important to note that the issue at hand is not AP courses, but whether we want to continue our policy of giving a weighted grade as a part of an AP class. The District strongly supports the offering of AP courses and is confident that the overall quality of the AP Program at KPBSD remains high. Also of note is that students do not need to take the end-of-course exam to be eligible for the weighted grade. I mention this since some argue that taking an AP class is a good indicator of future college success. This is not accurate. A strong score on the AP exam is the good indicator of success in college.

Finally, earlier this year a student stated to you that it was unfair that AR 6146.1 did not apply to college courses. Gary Turner, Director of KPC, has prepared a list of college courses that he feels are worthy of the same weighted grade status as the AP courses. This list is included with this memo.

Reason for Review: Some of our parents and students consider weighted grades to be divisive since those that have the opportunity to privately travel to another high school for an AP course have an unfair advantage in GPA calculation at their home school. The request to expand AR 6146.1 to include weighted grades for college courses also needs your consideration.

Possible Recommendations

- 1. Refer AR 6146.1 to the Policy Committee for their review and possible revision
- 2. Leave AR 6146.1 as is

The current regulation creates a system that is unfair to all students. Students that can afford to take correspondence Advanced Placement (AP) classes in addition to those that are offered at KCHS or drive to other schools to take AP classes in addition to those offered that are offered at KCHS receive an advantage over those that cannot. Additional time spent by students driving to and from schools increases the potential risks to student safety.

The current system does not account for the fact that not all KPBSD schools offer the same number of AP courses. It assumes that all students who transfer to KPBSD or within KPBSD schools have the opportunity to take the same number of AP courses. The current system also assumes that all AP courses are equally demanding and that the grading requirements of those courses are equal. KPBSD is a diverse district with many schools who offer a wide variety of educational
