BACKGROUND INFORMATION					

As you are aware, the District received additional funding from the State of Alaska to provide additional Career and Technical Education opportunities for students in grades 7 - 12. With this change in funding, the district developed a plan to use a portion of the FY12 funds for upgrades and modifications of existing buildings to accommodate changes in programs offered at Seward High, Nanwalek, Kenai Central High and Skyview High. Budget Transfer 1077, in the amount of \$690,907, has been processed in order to provide funds to the Kenai Peninsula Borough for these capital projects.

The District has a Technology Plan in place to provide for replacement of computer equipment in schools each year. Part of the Tech Plan for this fiscal year includes replacement of CRT monitors with LCD displays. Funds are budgeted for the Tech Plan in the Equipment object code, but since these items cost less than \$500, they are considered Supplies. Budget Transfer 1101, in the amount of \$104,500, has been processed to move funds from the Equipment account to the Supply account to allow for this purchase.

Costs of Fuel for Heating at several schools have exceeded their budgets this fiscal year. Budget Transfer 1162, in the amount of \$150,822, moves funds from the Unallocated Fuel for Heating (\$74,051) and Unallocated Electricity (\$76,771) accounts to locations that have exceeded their original Fuel for Heating budgets.

The Charter School Oversight Committee approved a request from Aurora Borealis Charter School to provide the Kenai Peninsula Borough with funds to purchase land adjoining the school campus. Budget Transfer 1165, in the amount of \$90,000, has been processed to move funds from the school's carryover account for this purpose.

A budget is a financial plan created to allocate funds for estimated costs of programs and needs in accordance with the District's plans and goals. It is usually necessary to make changes to the original plan through the use of budget transfers, which follow Generally Accepted Accounting Principles (GAAP), as more information about actual costs becomes available and decisions about programs and circumstances are revised. Prior to approval, all budget transfer requests are reviewed in light of current policies and procedures and evaluated for appropriateness and necessity in conjunction with the District's internal controls.

These budget transfers exceed \$50,000; therefore, they require Board of Education approval per Board Policy 3120.

ADMINISTRATIVE RECOMMENDATION

The administration has given preliminary approval, pending review and approval by the board. Approval by the Board of Education is recommended.
