- 6) Executive Secretary report/communications
 - a. Approved Voznesenka 6th graders being able to practice with the Middle School Wrestling team. They may only wrestle against other 6th graders in exhibition matches at district tournaments. They are not to travel to tournaments where 6th graders are not invited.

- 7) Action and Discussion items
 - ASAA Eligibility for Skyview Students 2014-2015 John O'Brien

At Tuesday's February 18th ASAA meeting, due to the reconfiguration and closing of Skyview High School, John O'Brien submitted a proposal on behalf of Skyview students. ASAA agreed to provide a onetime blanket waiver for the fall of 2014 allowing Skyview students the ability to establish their new school of eligibility. This goes into effect on the first day a student turns out for sport/activity practice in SY 2014-2015 at their new school or after enrolling and attending the new school for 15 school days.

Additionally, all 9th graders attending Soldotna Prep automatically establish So Hi as their high school of eligibility. ASAA will combine the enrollments of Soldotna Prep and So Hi for classification purposes. John O. will work with Pegge Erkeneff and the principals of schools affected on a communication plan for students, parents, coaches, and the community.

Increase activity bus driver wages to attempt to recruit more drivers – Tony Graham

Motion was made by Curtis Schmidt to table this item for more research; i.e. competitive wage package.

Sarge Truesdell presented his desire, due to declining enrollment and practice space difficulty, to eliminate two 'A' teams in Soccer, Volleyball and Basketball. John O'Brien expressed the importance of having as many kids participate as possible.

Tony Graham moved for soccer to have an 'A' and 'B' team next year. The board seemed comfortable with soccer but was not comfortable changing anything for volleyball and basketball. SMS will continue with two 'A' teams for volleyball and basketball. SMS is encouraged to use the 'B' team stipends it has allocated to maximize student involvement and participation in those sports. Sarge will work with John on the possibility of each 'A' team having single grade membership at SMS i.e. a 7th grade 'A' team and an 8th grade 'A' team.

Middle School Soccer language regarding 8 member team (tabled from November meeting)

Trevan Walker moved to approve as amended the following in the XII. Activity Rules, Soccer (Boys and Girls) in the KPSAA Middle School Handbook.

"3. Each team shall consist of eleven players, one of whom shall be the goalkeeper. At local contests and tournament play, a minimum of an eight-member team may be used if a school is unable to field eleven players. The opposing team will not be required to play the same number of players. They may use a full squad of eleven players if available." Amy Johnson seconded the motion.
